October 31, 2013


On Sunday, September 22nd Volusia County lost one of its pioneers in Traffic Safety with the passing of Palmer Malcom Smith Jr.

When Malcom Smith began working in Volusia County it was a 5 light county. When Malcom retired in 1999 as Volusia's first traffic engineer after 26 years of service the number of signals had swelled to 280. Before coming to Volusia County Smith served as the traffic engineer of Savannah, Ga and Washington, DC. Malcom recently served as the co-chair of the West Volusia County Community Traffic Safety Team

 $\operatorname{Mr.}$ Smith was born in Tampa, and moved to DeLand in 1973 .

He was a member of Rotary and many other organizations.

Mr. Smith is survived by two brothers, four children and eight grandchildren.

Starting **October 1st**, drivers in Florida could get a ticket for texting while driving. Drivers can still talk on the phone, but they will no longer be able to type on the phone. Drivers will also be allowed to text while stopped at a red light -- the law only applies when the vehicle is moving. It's a secondary offense, meaning an officer can't pull someone over for just texting. The driver would have to be committing another violation, like speeding or not wearing a seat belt.

If ticketed, drivers will have to pay a \$30 fine
